Instructions for Authors

In order to ensure uniformity in the series, authors should follow the bellow guidelines when preparing their Working Paper. The author is recommended to use the template provided for on the CEJE website: www.ceie.ch.

Content and structure of the papers

Papers include the following elements:

- cover sheet containing: complete title of the Paper, details of the author (Name of the author, address, email address, phone number), University and/or Research Center of affiliation (address, website)
- abstract of 250 words in English **and** in French and a maximum of 10 keywords in each language
- overview
- list of abbreviations
- main text
- annexes (if exist)
- full Bibliography (doctrine and case law)
- table of contents (with page indications)

Format the Geneva Jean Monnet Working Papers

1. Police, paragraphes and writing guidelines

The Working Papers contain between 8'000 and 15'000 words (main text and footnotes included).

Format A4

Main text

Font: Garamond

Size: 13

Space: before and after 10.5 pt Interlining: exactly 18 pt

Footnotes

Font: Garamond

Size: 8.5

Space: before and after 0 pt Interlining: multiple 1.1



Numbering of pages should start after the abstracts and keywords. Numbering of pages is placed at the bottom right of the page. The first page of the text will not contain a page number. Titles in the main text should follow this structure: I., A., 1., a. Italic format is used for foreign words as well as for quotes in the main text, which should be between quotation marks.

2. Quotation guidelines

The authors must apply a uniform way of quotation. The quotations of references in a language other than English and French are not an exception to this rule.
